On Wednesday February 17, 2021 at 6 pm, the Town of Townsend Board of Adjustment will hear a request from Townsend Village Maintenance Corporation for a variance from §66-720 and related Codes to install community signs that are approximately 44 sq. ft. in size, at the southeast corner of the intersection of Karins Boulevard and Karins Circle, and the east side of Wiggins Mill Road approximately 309 feet from the intersection of Andy Street.




<u>Materials</u>: The area will be excavated before laying a 6 inch crush and run stone base and 6 inches of concrete with a mesh rebar, then cinder block installed to apply the veneer stone using country Ledgestone (Color-Ashfall) and a masonry cement.

Signage Placement:


