IV. Review, discuss, and possible vote on recommendations to Town Council for approval, conditional approval, or recommendations against approval of the Townsend Acres preliminary subdivision plan.

Summary of the history of Townsend Acres original presentation, variances requested, and approval of the variances. Letters from the Town Engineer and Townsend Fire Department approved the plan as written. Mr. Curran stated that the developer is willing to include a mountable center median.

V. Discuss Woods at Hidden Creek response for a request of a complete and comprehensive plot plan showing parking lot and clubhouse in the community

We don't need an entire new plan. Code has been met we just want to see the plan. Land has been cleared but building has not started because of weather, lack or workers and supplies.

Also Middletown and Odessa are allowed to review our plan for comments. Question was asked if our PC gets to review Middletown and Odessa comp plans. Unsure of the answer, but Mayor will find out. The plans may have already been presented to the Town Manager to review. We did receive the 25 yr. NCC comp plan.
