1. All work to be performed on this project is at straight time. There are no multiple shifts or holidays included.
2. There are no provisions in this proposal for offsite parking or storage of material.
3. Sanitary toilet facilities and water service are to be provided by the General Contractor.
4. An adequate number of construction drawings and any other documents are to be supplied by the General Contractor.
5. Permanent power for testing to be paid by others, or any service fee's, taxes, etc.
6. *Generation Electrical Services* will provide the General Contractor with any and all information to assist in the creation and development of the Electrical Activities for the Construction Schedule.
7. *Generation Electrical Services* will follow all the General Contractor's Safety Rules as well as all OSHA Regulations and execute *Generation Electrical Services* Construction Safety and Drug Free Work Place Program. *Generation Electrical Services* will provide sufficient number of qualified workers to perform the work in sequence with the mutually agreed upon construction schedule.

8. *Generation Electrical Services* will expect the General Contractor to furnish all safety closures and barricades to assure the site is a safe environment to work in.
9. No provisions have been included in this proposal for design errors or omissions unless otherwise noted herewith.
10. No back charges will be accepted unless prior written notice and 48 hours have been given to reply
11. Performance and Payment Bonds are excluded unless noted otherwise.

QUALIFICATIONS

- This quotation is based on the following qualifications, exceptions, inclusions and exclusions as shown. Any and all deviations from this 'scope of work' will constitute a change in the amount quoted. We have not included any of the mechanical ductwork, or the unit heaters in this quotation.
- Specification section: Division 26 on plans
- Addenda acknowledged:
- Contract based on the latest version of AIA A401 or pre-negotiated terms.
- This proposal shall become an attachment to any contract entered into.
- No attempt has been made to review documents other than the electrical. All work not shown on the electrical drawings is specifically excluded. No changes will be made in design without the written approval of the project electrical engineer. Changes in the design shall be interpreted as a change which effects the capacity, reliability, cost, operation, location, or any part thereof, including changes which may be required to conform to National, State, or local regulations and/or codes.
- All work shall comply with national and local code requirements as designed by the project engineer and as indicated on the electrical drawings. Any applicable code items that may be required by local authorities and have not been shown on the project documents are not included in this proposal, inclusive of any items left to interpretation by local building authorities. We will not assume the liability nor accept any responsibility for the design, or redesign of engineered issued drawings to achieve code compliance without amended documents issued by the project architect and/or electrical engineer.
- Quote is based on normal working hours of 7:00 am to 3:30 pm Monday thru Friday.
- The cost of the following is excluded from this contract: More than 1 hour of safety training, Drug testing and Background checks.
- This proposal is based on insurance limits presently in effect at *Generation Electrical Services*. Any additional requirements may add additional costs to this proposal.
- If invoices from GES are not honored within 30 days of receipt a "STOP WORK ORDER" will be in effect until full payment of delinquent invoice has been received.
- If services of an attorney or collector are employed to collect any portion of amount due all fees and cost connected with the collection of the amount due will be assessed and paid by the debtor.
- All material provided by GES shall remain their property until full project value has been paid. This is to include change orders & additional work. Failure to remit payment per terms herein entitles GES to repossess the property described in the contract on demand without notice. It shall be understood and agreed that GES shall not be responsible for any damages caused by the removal of said property herein in this contract.
