## TOWN OF TOWENSEND PARK BASEBALL/MULTI-PURPOSE FIELD Rules and Policies

- 1.) A \$100 organization & a security deposit of \$100.00 is required at time contract is signed.
- 2.) If the Town is not required to clean or fix the field, the deposit will be refunded at the end of the season.
- 3.) If the field is very wet, please do not use it.
- 4.) User is responsible for set-up.
- 5.) User is responsible for all clean-up, including raking the field.
- 6.) User is responsible for any damage during use.
- 7.) User is responsible for the conduct of all the guests.
- 8.) User is responsible for ensuring guests park in designated parking lots, not on Edgar Road.
- 9.) Park is open dawn to dusk only.
- 10.) Loitering, fighting and/or weapons of any kind are explicitly prohibited on the premises.
- 11.) Illegal drugs are explicitly prohibited on the premises.
- 12.) NO alcohol permitted on the premises.
- 13.) Vehicles are NOT permitted on any grass area, regardless of loading and unloading.
- 14.) The Town of Townsend is not liable for any lost or stolen property.
- 15.) The Town of Townsend is not liable for injury or loss of life.
- 16.) The Park will remain open to the public during your use of the field.
- 17.) Have respect for others using the park.
- 18.) User must supply copy of driver's license or valid picture ID before signing contract.
- 19.) If any of the above rules are broken, the use of the ball field will be discontinued immediately, and no money will be refunded.
