## A. Roll Call

- III. **Minutes from the November 8<sup>th</sup> Planning Commission meeting to review and approve.** James moved to approve the minutes from the November 8<sup>th</sup> Planning Commission minutes. Lisa seconded. All voted to approve the minutes.
- IV. Update on PLUS (Preliminary Land Use Service) application for updates to Future Annexation

  Map. Antonina submitted an application and advised it was held with the need for the Town to clarify
  the map and to meet with New Castle County (NCC). NCC expressed concerns that the Planning
  Commission (PC) is changing the future annexation. NCC wants the PC to investigate Area A deed
  restrictions and Part B greenbelt areas before moving forward; these areas are not annexed yet.

  Antonina asked Troy and James if anything was mentioned on this before. James recalled that Part B
  greenbelt could not be annexed. Neither Troy nor James could remember anything regarding Area A
  deed restrictions. Antonina will continue to talk with NCC concerning Area A to get more information
  and clarity. Troy's not sure why Area A would be an issue because there are homeowners looking to

- potentially be annexed into Townsend. Antonina will send an email if she has an update before the next meeting.
- V. **Discussion regarding Chapter 24 Appendix B of the Town's Municipal Code.** The PC will review "Townsend\_Planning\_Process\_Update" from the Town Engineer to see if anything should be incorporated into the draft flowchart as well as other towns. The PC will review and send Antonina updates for January.
