 - **a.** TM Goodyear advised Chairman Wiggins of his duties for the Committee and confirmed staff support would include herself, PWS DiMartino, and TC Rivera.

 - TM Goodyear advised the garden at the Town Park will need to be reestablished; noting, the location chosen was not the best due to the lack of sun and access to water. TM Goodyear suggested another location may need to be chosen.

- d. C Wiggins advised he would like to host a meeting at the Town Park or other locations to better engage the community. C Wiggins explained the meeting format should be non-formal format so that residents can voice their concerns and/or opinions. CM Wiggins suggested even walking through the Town to engage the community.
- **e.** TM Goodyear suggested the following small-scale events to engage the community:

- **f.** TM Goodyear advised the Town may partner with local businesses and organizations for events.
- g. Ms. Augustus Gilbert stated she is of the Alpha Kappa Alpha Sorority; noting, the local chapter is Alpha Alpha Tau Omega. Ms. Pat Augustus Gilbert explained their chapter has been around for approximately three years and is committed to community service. Furthermore, as the Chairperson of Enhance Our Environment, which actively engages the surrounding community, she offered the Town their services to assist in any community efforts.

TM Goodyear advised the Town may solicit donations to stock the pantries.
