 - A. TM shares that in section 8.4.10, Chief Longo did not propose any changes.

 - B. TM shares in section 8.4.20, Chief Longo would like to add from DE code Title 11, criminal mischief in front of this.
 - 1. TM explains she would like to just site the title referring to DE code.

- E. TM shares in section 8.12.20, Chief Longo proposed changes per the Att. General. And to only reference the DE Code and removing Town verbiage.
 - 1. All agreed.
- F. TM shares in section 8.12.40, Chief Longo proposed adding DE code title 11.13.11 as a misdemeanor.
 - 1. All agreed.
- G. TM shares in section 8.16.10, Chief Longo did not propose any changes.
 - 1. All agreed.
- H. TM Shares in section 8.16.20, Chief Longo did not propose any changes.
 - 1. All agreed.
- I. TM Shares in section 8.16.30, Chief Longo did not propose any changes.
 - 1. CM Chapman requested more inclusive language in this section to reflect all.
 - I. TM Goodyear agrees and will make edits accordingly.
 - 2. Cm Chapman also requested that there be an alignment with the DE Code in reference to minors, such as a warning or ticket to a parent/guardian since they are responsible for the minor.
 - Chief Longo states there is already a procedure in place for this. The first offence is usually a verbal warning and afterwards it is at the officer's discretion.
 - a. Cm Chapman recommends giving a warning to the parents for the first offence.
 - Chief Longo states he does not have the authority to present a ticket to the parents. It would have to be the Town that issues a violation or letter for the offence.
 - b. TM asks if there would be an applicable fee with the violation.
 - i. Chief Longo recommended what is listed in accordance with the fee schedule.

VIII. ACTION ITEM: Code Sections 18 Rentals.

A. CM Chapman recommends looking at a later date to cut, delete, and rewrite of a lot of these sections to simplify the code and remove unnecessary liability from the Town. He also recommends simplifying the rental license process for people with multiple rentals.

- 1. TM Goodyear argues that the rental license process is already simplified for people with multiple properties.
- B. CM Chapman would also like to review the rental inspection process to protect the Town of future liabilities as responsibility lies solely on the property owner as well as cutting down on inspection costs for the Town.

- C. CM Chapman recommended converting the rental license into a business license since it is a business transaction.
 - 1. Mayor Lobdell agrees with this recommendation.
