 - **b.** TM Goodyear showed signs that were created to advertise for the Town Fair which will be posted locally. She also shared the Town Fair t-shirts for staff and volunteers which can be collected after the meeting.

 - b. CM Wiggins asked if we could rent a tent and chairs and have it near the pavilion with the caterer in the tent so that way people will have the option to eat or drink where they would like.
 - c. PWS Boyer stated we can still hold the drinking area in the tennis court if need be. PW confirmed they can remove the net before the event for safety.
- **e.** TM Goodyear asks the attending staff to be assigned tasks so we can be prepared for the day.
 - 1. PWS Boyer, his son, and a volunteer are going to be assigned to parking.
 - 2. TC Gallagher and husband are going to man the dunk tank booth.
 - 3. CM Wiggins and TC Gallagher are going to direct hired vendors to their assigned spots.
