



# Town of Townsend

## Business License Application

Business Licenses are *required* for any business operating within the Town of Townsend. ***If your business address is located outside of the Municipality, please apply for a Contractor License;*** any contractor holding a Business License with the Town of Townsend is exempt from obtaining a Contractor License. A Business License issued by the Town is only valid with current insurance and State Licenses.

### Terms & Conditions

**Section 1** - No person shall conduct or engage in any trade, business or occupation within the Town of Townsend for which a license is required without first having obtained a license therefore and paid the license fee prescribed as listed below.

**Section 2** - Licenses shall be required for the following trades, businesses and occupations in the Town of Townsend and the license fee shall be set forth beside the names of said trades, businesses and occupations in the Town of Townsend.

**Section 3** - Manufacturers shall pay a license fee at the rate of .0005 of the aggregate gross receipts over \$400,000; provided, however, that the minimum license fee shall be one hundred and thirty dollars (\$130.00). Merchants and bottlers shall pay a license fee at the rate of .00046 of the aggregate gross purchases for resale over \$400,000; provided, however, that the minimum license fee shall be seven hundred and fifty dollars (\$750.00). Businesses will sign an affidavit stating their aggregate gross receipts or aggregate gross purchases for resale. Exemption: Any manufacturer that has aggregate gross receipts or any merchant or bottler that has aggregate gross purchases for resale under \$100,000 will pay a license fee of \$125.00. However, the licensing office must receive a letter stating this by January 31st. Please reference attachment.

**Section 4** - Each license granted under this Ordinance shall not be transferable.

**Section 5** - License shall be displayed in a conspicuous manner in the principal office in the place of business in the Town of Townsend.

**Section 6** - Any person convicted of a violation of the provisions of this Ordinance shall be fined not less than ten dollars (\$10.00) nor more than one hundred dollars (\$100.00), or upon failure to pay such fine as imposed, shall be imprisoned for not more than thirty (30) days.

**Section 7** - The premises of every licensee shall be open to the inspection of the Fire Marshal, Board of Health and all applicable Town Officers during all business hours.

**Section 8** - All Ordinances or parts of Ordinances inconsistent with this Ordinance are hereby repealed to the extent of such inconsistency.

**Section 9** - There is a penalty If the license fee is not paid by February 15 of each year, then a penalty in the amount of ten (10%) percent per month of the amount of license fee will accrue until payment is received. Each day the license fee is delinquent shall constitute a separate violation and a summons may be issued to initiate a criminal prosecution for each day that the license fee goes unpaid.
